Last but not least, professional services supporting trade in technology will provide informative and valuable assistance in the fields of technology transferring & licensing, intellectual property protection, technology financing, talent services and investment promotion.

Professional Services Pavilion

CSITF will dedicate a professional services area to provide professional services relating to trade and transactions in technology. Including:

Technology Transferring & Licensing

This is composed of domestic and international technology exchange organisations, and technology trade intermediaries. It will provide services including technology consultation, technology evaluation, technology transfer and licensing.

Intellectual Property Protection

This is composed of professional lawyers in intellectual property rights and experts from intellectual property administrations to provide legal services in applications, licensing and transfer, complaints of infringements in patents, trademarks and copyrights related areas.

Investment and Financing

This comprises national and international banking institutions, insurance, venture capitals, private equity, and angel funds etc, to provide investment and financing services for industry technology.

Talent Services

This comprises technology talent consulting firms and etc. to establish a platform of assimilation and exchanges of talents in high-end technology and provide advice and consultancy on policy consultation, talent evaluation talent planning and talent motivations.

Investment Promotion

This comprises cutting-edge technology parks, technology incubators and related government services departments to provide services in technology incubations, policy promotion of investment settlement and consultations.







Forums & Events

Opening Ceremony and Summit

With the theme of "Innovation-driven Development", the presentations and interactive summits will evolve around topics such as: the supporting and leading role of technology in transforming economic development mode and economic restructuring, establishment and improvement of knowledge transfer, technology dispersion, transfer and conversion mechanisms, and enhancement of companies' innovation capabilities. We will have the presence of Government Officials, Nobel Prize-winners, CEOs from cutting edge technology enterprises from around the world, Renowned university professors and scholars, and R&D leaders from global top 500 companies.

Theme Forums

Gathering senior participants from political policy makers, international R&D centers in various industries, multinational corporations, legal institutions and financing institutions, with themes of policy introduction, industrial technology areas, intellectual property protection, technology financing, the Forums will further interpret government industrial policies, analyze status quo and potential of technology development, explain market application prospects and elaborate professional services. Participants will have experience, exchanges and interactions from multiple perspectives, which will be an ultimate display of "New Technology, New Market, New Network"- the CSITF's objective.

Seminar & Workshop

The organizing committee of CSITF encourages all exhibitors to offer technology promotions and innovation demonstrations and workshops during the fair, in order to fully display each exhibitor's new technologies and technical solutions to improve technology exchanges, application co-operations, and transfer licensing. Any exhibitor with such demonstrations will be given priority in applying for exhibition space and activities schedule, as well as full support from the organizing committee in publicity and promotional activities and invitations of professional visitors.
